

## Invitation to Bid

### Improvement of Various Irrigation Facilities of AMRIS Lat. D-1-A, D-1-B, D-1-D, D-2, Lat. C-2-A, Lat. C-2-A, Lat. C-2-E, Lat. C-2-01, Lat. C-2-H, Dam 2, Dam 2A, Lat A, Lat B, Lat C, & D-9

1. The **NATIONAL IRRIGATION ADMINISTRATION – REGION 3**, hereby invites all interested Phil-GEPS registered contractors to bid for the project, through the General Appropriations Act of CY 2020, intends to apply the sum of **Fifty Two Million Nine Hundred Seventy Thousand Seven Hundred Sixty Five Pesos and 39/100 (P 52,970,765.39)** being the Approved Budget for the Contract (ABC) for the contract for **No.NIAR3-2020-BUL-AMRIS-21** Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. Bidders must secure Site Inspection Certificate from IMO Office as a technical requirement for Eligibility and Technical Document (Envelop A). Non-compliance will be a ground for disqualification.
3. Only those who submitted Document Request List (DRL) from PhilGEPS including updated company profile by the owner or its authorized liaison officer, will be accepted to participate in the bidding.
4. The **NATIONAL IRRIGATION ADMINISTRATION – REGION 3** now invites bids for **Improvement of Various Irrigation Facilities of AMRIS Lat. D-1-A, D-1-B, D-1-D, D-2, Lat. C-2-A, Lat. C-2-A, Lat. C-2-E, Lat. C-2-01, Lat. C-2-H, Dam 2, Dam 2A, Lat A, Lat B, Lat C, & D-9, located in Apalit, Candaba & San Luis Pampanga.** Completion of the Works is required within **Three Hundred (300) calendar days**. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.
5. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act”.  
  
Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
6. Interested bidders may obtain further information from **NATIONAL IRRIGATION ADMINISTRATION – REGION 3** and inspect the Bidding Documents at the address given below from 9:00 A.M. to 4:00 P.M., Monday to Friday.
7. A complete set of Bidding Documents may be purchased by interested Bidders on **November 28, 2019 to December 19, 2019 from 9:00 a.m. to 4:00 p.m., Monday to Friday, except and holidays and November 20, 2019 from 9:00 a.m. to 12:30 a.m.** from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of **Fifty Two Thousand Pesos (P 52,000.00)**

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (**PhilGEPS**) and the website of the Procuring Entity,

provided that bidders shall pay the fee for the Bidding Documents not later than the submission of their bids.

8. The **NATIONAL IRRIGATION ADMINISTRATION – REGION 3** will hold a Pre-Bid Conference on **December 6, 2019, 10:00 a.m.** at **NIA-R3 Office, Conference Room, Brgy. Tambubong, San Rafael, Bulacan**, which shall be open to all interested parties.
9. Bids must be duly received by the BAC Secretariat at the address below on or before **12:30 a.m. (PST) of December 20, 2019** at **NIA-R3 Office, Conference Room, Brgy. Tambubong, San Rafael, Bulacan**. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on **1:00 p.m. (PST) of December 20, 2019** at **NIA-R3 Office, Conference Room, Brgy. Tambubong, San Rafael, Bulacan**. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

10. All particulars relative to the eligibility screening, bid security, performance security, pre-bid conference/s, evaluation of bids, post qualification and award of contracts shall be governed by the pertinent provisions of RA 9184 and its revised IRR.
11. The **NATIONAL IRRIGATION ADMINISTRATION – REGION 3** reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
