KNOW ALL MEN BY THESE PRESENTS:

This Contract is executed and entered into this 24th day of February, 2022 at Tambubong, San Rafael, Bulacan, Philippines, by and between:

The **National Irrigation Administration**, hereinafter referred to as the NIA, a government instrumentality created under Republic Act No. 3601, as amended by Presidential Decree No. 552 with principal office at NIA Building, Epifanio Delos Santos Avenue, Diliman, Quezon City, represented herein by its Regional Manager, **JOSEPHINE B. SALAZAR** who is duly authorized to represent it in this Contract;

FRAMECON BUILDERS herein referred to as the Contractor, a private entity duly organized and existing under and by virtue of the laws of the Republic of the Philippines with principal address at **San Anton, San Leonardo, Nueva Ecija** represented by its Manager **ROMANITO R. JUATCO** who is duly authorized to represent said firm in this Contract;

WITNESSETH, THAT

WHEREAS, the NIA in its Invitation to Bid Number : **NIAR3-2022-TAR-TASMORIS -ARMENIA DAM-11** called for tenders for the **Improvement/Rehabilitation of TASMORIS Armenia Dam** located in **La Paz and Victoria, Tarlac** and in accordance with the Bid Documents;

WHEREAS, on **February 9, 2022** the Contractor submitted the lowest responsive bid for the above-mentioned works in the total amount of **NINETY TWO MILLION SIX HUNDRED THIRTY FIVE THOUSAND SEVEN HUNDRED SIXTY ONE & 73/100 PESOS ONLY (P 92,635,761.73);**

WHEREAS, NIA finds this bid of the CONTRACTOR to be the lowest calculated and responsive bid, the same being **P 92,635,761.73** or **P 919,209.77** lower than the Approved Budget for Contract (ABC) of **P 93,554,971.50** ;

NOW, THEREFORE, for and in consideration of the foregoing premises, the parties have mutually agreed and do hereby agree as follows:



C - 2 ACCEPTANCE OF BID

The NIA has accepted the offer of the CONTRACTOR for the **Improvement/ Rehabilitation of TASMORIS Armenia Dam, La Paz and Victoria, Tarlac**, in conformity and in accordance with and subject to all of the terms & conditions of the Contract Documents and as provided in the Contract;

It is expressly agreed by both parties that no upward change in the Contract price as of the date of the signing of this Agreement shall be made as a result of among others, any fluctuation in the cost of materials and labor or for any reason whatsoever.

C - 3 AGREEMENT

The Contractor agrees to furnish all equipment, supplies, materials, labor, superintendence and other incidentals and to perform and complete all of the Contract Work under this Contract and the NIA agrees to pay for such, as described in the Contract Documents.

C - 4 OBLIGATIONS OF CONTRACTOR

The Contractor agrees to perform well and faithfully all of the contract works indicated in the contract documents and as described in Clause C-1 herein before, and to furnish all of the equipment, materials, supplies, labor and superintendence and other facilities requisites for or incidental to the successful completion of the works and the carrying out of all the duties and obligations imposed by the Contract Documents.

The Contractor agrees to satisfactorily complete all of the contract works under Contract within **Three Hundred (300)** calendar days from receipt of the Notice to Proceed.

The Contractor also agrees to hire laborers at least fifty (50%) percent of the required manpower in the contract works from the member of Irrigator's Association wherein the project will be undertaken.

C - 5 OBLIGATIONS OF THE NIA

The NIA agrees, subject to the terms and conditions in the Contract Documents, to pay to the Contractor the total amount of: **NINETY TWO MILLION SIX HUNDRED THIRTY FIVE THOUSAND SEVEN HUNDRED SIXTY ONE & 73/100 PESOS ONLY (P 92,635,761.73)** at the rates and times and in the manner set forth under the General Conditions of the Contract and in the Contract Documents.

C - 6 MUTUAL OBLIGATIONS

The NIA and the Contractor mutually agree to perform, fulfill, abide by and submit to any and all of the provisions and requirements and all matters and things contained or expressed in, or reasonably to be inferred from the contract documents.

C - 7 LIQUIDATED DAMAGES

The parties hereby expressly agree that Liquidated Damages, under this Contract, shall be settled in accordance and subject to such terms and conditions as set forth under GCC - Article 9 of the General Conditions and other pertinent provisions of the contract documents.

C - 8 PERFORMANCE BOND

In compliance with the conditions in the contract documents, the contractor hereby posts his Performance Security in form of Performance Bond in the amount of : **(P 27,790,728.52) TWENTY SEVEN MILLION SEVEN HUNDRED NINETY THOUSAND SEVEN HUNDRED TWENTY EIGHT & 52/100 PESOS ONLY** which is valid and in effect for the entire duration of the contract, including any extension.

The Performance Security shall be released by the NIA after completion of the works and issuance of the Certificate of Completion, provided liquidated damages and other claims, if any, had been settled and the submission of an acceptable guarantee bond (surety bond) to be issued by the GSIS or any reputable bonding institution acceptable to NIA equivalent to 30% ; or cash deposit, cash bond, irrevocable letter of credit or bank guarantee of 10% of the final contract amount to assure NIA that the Contractor shall made good any defects that may be found in the project within a period of one (1) year from the acceptance thereof, it being understood that nothing in these condition extinguishes that liability of the Contractor for damages, except those occasioned by force majeure, within 15 years from the completion of the project, if the same should collapse on account of defects in the construction and the use of materials of inferior quality furnished by it or due to any violation of the terms of the contract, as provided for in the Civil Code.

For this purpose, the document transmitting and/or evidencing the performance bond in the form of cash, manager's check, cashier's check, bank guarantee, letter of credit, surety bond or a combination thereof, shall contain the following;

C - 10 INTEGRATION

The NIA and the CONTRACTOR agree that this Contract including the contract documents, expresses and integrates all of the agreements, understandings, promises and covenants of the parties and supersedes all prior and contemporaneous negotiations, understandings and agreements, whether written or oral and that no modification or alteration of this Contract shall be valid or binding to either party unless expresses in writing and executed with the same formality as this Contract except as may otherwise be specifically provided in this Contract.

C - 11 JURISDICTION

The parties hereby mutually agree that the venue of the action for any cause or causes of action which may arise from this Contract shall be the proper court of BULACAN.

C - 12 COUNTERPARTS

The Contract is executed in five (5) identical counterparts, four (4) copies for the NIA, one (1) for the CONTRACTOR.

C - 13 WARRANTY

The CONTRACTOR warrants that it has not given or promised to give any money or gift to any official or employee of the NIA and any violation of the warranty shall be sufficient ground for the NIA to revoke or extra judicially cancel this contract.

C - 14 DOCUMENTATION

Documentation/Notarial fees and documentary stamps in connection with this contract shall be for the account of the CONTRACTOR.


C - 15 APPROVAL

This contract shall be subject to the approval of proper authorities in accordance with pertinent laws, rules and regulations.




