WHEREAS, the NIA in its Invitation to Bid Number : NIAR3-2022-TAR-TASMORIS-9 called for tenders for the Improvement of Canal System and Irrigation Facilities of TASMORIS (San Miguel – O'DonnellRIS/Aduas-Balayang) located in La Paz, Tarlac and in accordance with the Bid Documents;

WHEREAS, on February 9, 2022 the Contractor submitted the lowest responsive bid for the above-mentioned works in the total amount of FORTY SIX MILLION FOUR HUNDRED NINETY SEVEN THOUSAND TWO HUNDRED THIRTY SEVEN & 92/100 PESOS ONLY (P 46,497,237.92);

WHEREAS, NIA finds this bid of the CONTRACTOR to be the lowest calculated and responsive bid, the same being P 46,497,237.92 or P 411,291.58 lower than the Approved Budget for Contract (ABC) of P 46,908,529.50;

The Contractor also agrees to hire laborers at least fifty (50%) percent of the required manpower in the contract works from the member of Irrigator's Association wherein the project will be undertaken.

#### **OBLIGATIONS OF THE NIA** C - 5

The NIA agrees, subject to the terms and conditions in the Contract Documents, to pay to the Contractor the total amount of: (P 46,497,237.92) FORTY SIX MILLION FOUR HUNDRED NINETY SEVEN THOUSAND TWO HUNDRED THIRTY SEVEN & 92/100 PESOS ONLY at the rates and times and in the manner set forth under the General Conditions of the Contract and in the **Contract Documents.** 

#### **MUTUAL OBLIGATIONS** C - 6

The NIA and the Contractor mutually agree to perform, fulfill, abide by and submit to any and all of the provisions and requirements and all matters and things contained or expressed in, or reasonably to be inferred from the contract documents.

#### LIQUIDATED DAMAGES C - 7

The parties hereby expressly agree that Liquidated Damages, under this Contract, shall be settled in accordance and subject to such terms and conditions as set forth under GCC - Article 9 of the General Conditions and other pertinent provisions of the contract documents.

### **C - 8 PERFORMANCE BOND**

In compliance with the conditions in the contract documents, the contractor hereby posts his Performance Security in form of Performance Bond in the amount of : (P 13,949,171.38) THIRTEEN MILLION NINE HUNDRED FORTY NINE THOUSAND ONE HUNDRED SEVENTY ONE & 38/100 PESOS ONLY which is valid and in effect for the entire duration of the contract, including any extension.

The Performance Security shall be released by the NIA after completion of the works and issuance of the Certificate of Completion, provided liquidated damages and other claims, if any, had been settled and the submission of an acceptable guarantee bond (surety bond) to be issued by the GSIS or any reputable bonding institution acceptable to NIA equivalent to 30%; or cash deposit, cash bond, irrevocable letter of credit or bank guarantee of 10% of the final contract amount to assure NIA that the Contractor shall made good any defects that may be found in the project within a period of one (1) year from the acceptance thereof, it being understood that nothing in these condition extinguishes that liability of the Contractor for damages, except those occasioned by force majure, within 15 years from the completion of the project, if the same should collapse on account of defects in the construction and the use of materials of inferior quality furnished by it or due to
