# C-7 LIQUIDATED DAMAGES

The parties hereby expressly agree that Liquidated Damages, under this Contract, shall be settled in accordance and subject to such terms and conditions as set forth under Rule XXII – Civil Liability Section 68 Liquidated Damages of the 2016 Revised Implementing Rules and Regulations of R.A. 9184.

# C-8 PERFORMANCE BOND

In compliance with the conditions in the contract documents, the contractor hereby posts his Performance Security in the form of Performance Bond in the amount of Eleven Million Five Hundred Ten Thousand Four Hundred Eighty-Seven and 92/100 Pesos Only (P 11,510,487.92) which is valid and in effect for the entire duration of the contract, including any extension.
