KNOW ALL MEN BY THESE PRESENTS:

This Contract is executed and entered into this APR day of April, 2025 at Solib, Floridablanca, Pampanga, Philippines, by and between:

The NATIONAL IRRIGATION ADMINISTRATION, hereinafter referred to as the NIA, a government instrumentality created under Republic Act No. 3601, as amended by Presidential Decree No. 552 with principal office at NIA Building, Epifanio Delos Santos Avenue, Diliman, Quezon City, represented herein by PAMBAT IMO Division Manager, RUBEN R. LLAMAS, who is duly authorized to represent it in this Contract:

DMKC CONSTRUCTION AND TRADING CORP., herein referred to as the Contractor, a private entity duly organized and existing under and by virtue of the laws of the Republic of the Philippines with principal address at Blk 12 Lot 72 Rowena St., Mabalacat City, Pampanga represented by its Owner/General Manager, MARDY C. CASTRO who is duly authorized to represent the said firm in this Contract;

WITNESSETH, THAT


WHEREAS, the NIA, in its Invitation to Bid No. NIAR3-PAMBAT IMO-2025-PGRIS (GUMAIN RIS)-02 called for tenders for Improvement of Canal System of PGRIS (Gumain RIS) located in Lubao, Pampanga in accordance with the Bid Documents;

WHEREAS, on November 12, 2024, the Contractor submitted the lowest responsive bid for the abovementioned works in the total amount of EIGHTEEN MILLION NINE HUNDRED SEVENTY-EIGHT THOUSAND THREE HUNDRED SIXTY-SEVEN PESOS AND FIFTY-THREE CENTAVOS (PHP 18,978,367.53).

WHEREAS, NIA finds this bid of the CONTRACTOR to be the lowest calculated and responsive bid, the same being P 18,978,367.53 or P 107,624.21 lower than the Approved Budget for the Contract (ABC) of P 19,085,991.74;

NOW, THEREFORE, for and in consideration of the foregoing premises, the parties have mutually agreed and do hereby agree as follows:

All of the above documents are referred to herein as the Contract Documents and shall remain as the property of NIA.

It is expressly agreed and understood that in case of any irreconcilable conflict between this contract and the provision of any of the Contract Documents, the former shall be controlling.

C-2 ACCEPTANCE OF BID

The NIA has accepted the offer of the CONTRACTOR for the Improvement of Canal System of PGRIS (Gumain RIS) located at Lubao, Pampanga in conformity and in accordance with and subject to all of the terms and conditions of the Contract Documents and as provided in the Contract;

It is expressly agreed by both parties that no upward change in the Contract price as of the date of the signing of this Agreement shall be made as a result of among others, any fluctuation in the cost of materials and labor or for any reason whatsoever.


C-3 AGREEMENT

The Contractor agrees to furnish all equipment, supplies, materials, labor, superintendence, and other incidentals and to perform and complete all of the Contract Work under this Contract and the NIA agrees to pay for such, as described in the Contract Documents.

C-4 OBLIGATIONS OF CONTRACTOR

The Contractor agrees to perform well and faithfully all of the contract works indicated in the contract documents and as described in Clause C-1 herein before, and to furnish all of the equipment, materials, supplies, labor and superintendence and other facilities requisites for or incidental to the successful completion of the works and the carrying out of all the duties and obligations imposed by the Contract Documents.

The Contractor agrees to satisfactorily complete all of the contract works under the Contract within Two Hundred Forty (240) calendar days from receipt of the Notice to Proceed.

The Contractor also agrees to hire laborers at least fifty percent (50%) of the required manpower in the contract works from the members of the Irrigator's Association wherein the project will be undertaken.

C - 5 OBLIGATIONS OF THE NIA

The NIA agrees, subject to the terms and conditions in the Contract Documents, to pay to the Contractor the total amount of EIGHTEEN MILLION NINE HUNDRED SEVENTY-EIGHT THOUSAND THREE HUNDRED SIXTY-SEVEN **PESOS** AND **FIFTY-THREE CENTAVOS** (PHP 18,978,367.53) at the rates and times and in the manner set forth in the General Condition of Contract and in the Contract Documents.

MUTUAL OBLIGATIONS

The NIA and the Contractor mutually agree to perform, fulfill, abide by, and submit to any and all of the provisions and requirements and all matters and things contained or expressed in, or reasonably to be inferred from the contract documents.

LIQUIDATED DAMAGES

The parties hereby expressly agree that Liquidated Damages, under this Contract, shall be settled in accordance and subject to such terms and conditions as set forth under Rule XXII- Civil Liability Section 68 Liquidation Damages of 2016 Revised Implementing Rules and Regulation of R.A. 9184.


C - 8 PERFORMANCE BOND

In compliance with the conditions in the contract documents, the contractor hereby posts his Performance Security in the form of Performance Bond in the amount of Five Million Six Hundred Ninety-Three Thousand Five Hundred Ten Pesos and Twenty-Six Centavos (Php 5,693,510.26) which is valid and in effect for the entire duration of the contract, including any extension.

The Performance Security shall be released by the NIA after completion of the works and issuance of the Certificate of Completion, provided liquidated damages and other claims, if any, had been settled and the submission of an acceptable guarantee bond to be issued by the GSIS or any reputable bonding institution acceptable to NIA equivalent to 30%; or cash deposit, cash bond or irrevocable letter of credit or bank guarantee of 10% of the final contract amount to assure NIA that the Contractor shall made good any defects that may be found in the project within a period of one (1) year from the acceptance thereof, it being understood that nothing in these condition extinguishes that liability of the Contractor for damages, except those occasioned by force majure, within 5 years from the completion of the project, if the same should collapse on account of defects in the construction and the use of materials of inferior quality furnished by it or due to any violation of the terms of the contract, as provided for in the Civil Code.

For this purpose, the document transmitting and/or evidencing the performance bond in the form of cash, manager's check, cashier's check, bank guarantee, letter of credit, or a combination thereof, shall contain the following;

The NIA and the CONTRACTOR agree that this Contract including the contract documents, expresses and integrates all of the agreements, understandings, promises, and covenants of the parties and supersedes all prior and contemporaneous negotiations, understandings, and agreements, whether written or oral, and that no modification or alteration of this Contract shall be valid or binding to either party unless expresses in writing and executed with the same formality as this Contract except as may otherwise be specifically provided in this Contract.

C - 11 JURISDICTION

The parties hereby mutually agree that the venue of the action for any cause or causes of action which may arise from this Contract shall be the proper court of Pampanga.

C - 12 COUNTERPARTS

The Contract is executed in seven (5) identical counterparts, six (4) copies for the NIA and one (1) for the CONTRACTOR.

C - 13 WARRANTY

The CONTRACTOR warrants that it has not given or promised to give any money or gift to any official or employee of the NIA and any violation of the warranty shall be sufficient grounds for the NIA to revoke or extra-judicially cancel this contract.

C - 14 DOCUMENTATION

Documentation/Notarial fees and documentary stamps in connection with this contract shall be for the account of the CONTRACTOR.

C - 15 APPROVAL

This contract shall be subject to the approval of proper authorities in accordance with pertinent laws, rules, and regulations.
