The NIA-Tarlac Irrigation Management Office (NIA-TARLAC IMO), through the General Appropriations Act-Resto CIS of CY 2024 intends to apply the sum of Twenty Eight Million Seven Hundred Fifty Three Thousand Seven Hundred Eighty Nine Pesos & Fifty Six Centavos (₱ 28,753,789.56) being the Approved Budget for the Contract (ABC) to payments under the contract, Construction/Improvement of Irrigation Facilities of Magao CIS & Sta. Monica CIS located in the Municipality of Concepcion, Province of Tarlac with ITB No. NIA-TAR-2024-13-MAGAO CIS & STA. MONICA CIS. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The NIA – Tarlac Irrigation Management Office now invites bids for the above Procurement Project. Completion of the Works is required within Two Hundred Forty (240) Calendar Days. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from NIA – Tarlac Irrigation Management Office BAC and inspect the Bidding Documents at the address given below from Monday to Friday, from 10:00 a.m. to 2:00 p.m. except holiday.
5. A complete set of Bidding Documents may be acquired by interested bidders on December 8, 2023 to December 27, 2023 from 10:00 a.m. to 2:00 p.m., Monday to Friday, and December 28, 2023 from 8:00 a.m. to 8:30 a.m. except holidays from given address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Twenty Thousand Pesos (₱ 20,000.00).
6. The NIA – Tarlac Irrigation Management Office will hold a Pre-Bid Conference on December 15, 2023, 11:30 a.m. at NIA- TARLAC IMO Conference Room, Brgy. Jefmin, Concepcion, Tarlac.
7. Bids must be duly received by the BAC Secretariat through manual submission and addressed to the BAC Chairperson of the Procuring Entity at the office address as indicated below on or before 8:30 a.m. (PST) of December 28, 2023. Late bids shall not be accepted.


