Invitation to Bid for the
Supply and Delivery of 8-9HP Diesel Engine with 4x4 Centrifugal Pump
IB No. NIA-TAR-2024-22-STW PUMPS

1. The NIA-Tarlac Irrigation Management Office (NIA-TARLAC IMO), through the General Appropriations Act – GAA of CY 2024 intends to apply the sum of Nine Million Nine Hundred Ninety Six Thousand Pesos (₱ 9,996,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract, Supply and Delivery of 8-9HP Diesel Engine with 4x4 Centrifugal Pump with complete accessories for various Farmers Irrigators Association of the Province of Tarlac with IB No. NIA-TAR-2024-22-STW PUMPS. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The NIA – Tarlac Irrigation Management Office now invites bids for the above Procurement Project. Completion of the Works is required within Sixty (60) Calendar Days. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from NIA – Tarlac Irrigation Management Office BAC and inspect the Bidding Documents at the address given below from Monday to Friday, from 10:00 a.m. to 2:00 p.m. except holiday.
5. A complete set of Bidding Documents may be acquired by interested bidders on December 27, 2024 to January 13, 2025 from 10:00 a.m. to 2:00 p.m., Monday to Friday, and January 14, 2025 from 8:00 a.m. to 8:30 a.m. except holidays from given address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Ten Thousand Pesos (₱ 10,000.00).
6. The NIA – Tarlac Irrigation Management Office will hold a Pre-Bid Conference on January 2, 2025, 10:00 a.m. at NIA- TARLAC IMO Conference Room (Extension), Brgy. Jefmin, Concepcion, Tarlac.
7. Bids must be duly received by the BAC Secretariat through manual submission and addressed to the BAC Chairperson of the Procuring Entity at the office address as indicated below on or before 8:30 a.m. (PST) of January 14, 2025. Late bids shall not be accepted.
8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 15**.
9. Bid opening shall be on 9:00 a.m. (PST) of January 14, 2025 at NIA- TARLAC IMO Conference Room (Extension), Brgy. Jefmin, Concepcion, Tarlac. Bids will be opened in the presence of the bidders’ representatives who choose to attend the activity.
