



Invitation to Bid for Canalization and Slope Protection Works for AMRIS (UMD)

ITB No. NIAR3-2021-BUL-AMRIS-15

1. The **NATIONAL IRRIGATION ADMINISTRATION – REGION 3**, through the **General Appropriations Act of CY 2021** intends to apply the sum of **Thirty-Seven Million Nine Hundred Sixty-Two Thousand Five Hundred Ninety-Seven Pesos (P 37,962,597.00)** being the Approved Budget for the Contract (ABC) to payments under the contract **Canalization and Slope Protection Works for AMRIS (UMD)** located in **San Ildefonso, Bulacan with ITB No. NIAR3-2021-BUL-AMRIS-15**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **NATIONAL IRRIGATION ADMINISTRATION – REGION 3** now invites bids for the above Procurement Project. Completion of the Works is required **One Hundred Eighty (180) Calendar Days**. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from **NATIONAL IRRIGATION ADMINISTRATION – REGION 3 BAC** and inspect the Bidding Documents at the address given below from **Monday to Friday, from 9:00 a.m. to 4:00 p.m. except holiday**.
5. A complete set of Bidding Documents may be acquired by interested bidders on **January 22, 2021 to February 10, 2021 from 9:00 a.m. to 4:00 p.m., Monday to Friday, except holidays** from given address below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Thirty-Five Thousand Pesos (P 35,000.00)*.
6. The **NATIONAL IRRIGATION ADMINISTRATION – REGION 3** will hold a Pre-Bid Conference on **January 29, 2021, 10:00 a.m.** at **NIA-R3 Office, Conference Room, Brgy. Tambubong, San Rafael, Bulacan**.
7. Bids must be duly received by the BAC Secretariat through manual submission and addressed to the BAC Chairperson of the Procuring Entity at the office address as indicated below on or before **9:30 a.m. (PST) of February 11, 2021**. Late bids shall not be accepted.
8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 15.
9. Bid opening shall be on **11:30 a.m. (PST) of February 11, 2021** at **NIA-R3 Office, Conference Room, Brgy. Tambubong, San Rafael, Bulacan**. Bids will be opened in the presence of the bidders’ representatives who choose to attend the activity.
