



Invitation to Bid for *Maasim River Slope Protection - Improvement of Slope Protection*

ITB No. NIAR3-2021-BUL-MAASIM SLOPE-1

1. The **NATIONAL IRRIGATION ADMINISTRATION – REGION 3**, through the **General Appropriations Act of CY 2021** intends to apply the sum of **Thirty-Eight Million Two Hundred Thirty-Six Thousand Seven Hundred Nineteen Pesos and 96/100 (P 38,236,719.96)** being the Approved Budget for the Contract (ABC) to payments under the contract for **Maasim River Slope Protection - Improvement of Slope Protection located in Candaba, Pampanga with ITB No. NIAR3-2021-BUL-MAASIM SLOPE-1**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **NATIONAL IRRIGATION ADMINISTRATION – REGION 3** now invites bids for the above Procurement Project. Completion of the Works is required **Three Hundred (300) Calendar Days**. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from **NATIONAL IRRIGATION ADMINISTRATION – REGION 3 BAC** and inspect the Bidding Documents at the address given below from **Monday to Friday, from 9:00 a.m. to 4:00 p.m. except holiday**.
5. A complete set of Bidding Documents may be acquired by interested bidders on **December 17, 2020 to January 7, 2021 from 9:00 a.m. to 4:00 p.m., Monday to Friday, and January 8, 2021 from 9:00 a.m. to 9:30 a.m., except holidays** from given address below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of* **Thirty-Eight Thousand Pesos (P 38,000.00)**.
6. The **NATIONAL IRRIGATION ADMINISTRATION – REGION 3** will hold a Pre-Bid Conference¹ on **December 28, 2020, 10:00 a.m.** at **NIA-R3 Office, Conference Room, Brgy. Tambubong, San Rafael, Bulacan**.
7. Bids must be duly received by the BAC Secretariat through manual submission and addressed to the BAC Chairperson of the Procuring Entity at the office address as indicated below on or before **9:30 a.m. (PST) of January 8, 2021**. Late bids shall not be accepted.

¹ May be deleted in case the ABC is less than One Million Pesos (PhP1,000,000) where the Procuring Entity may not hold a pre-bid conference.

8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 15.
9. Bid opening shall be on **10:00 a.m. (PST) of January 8, 2021** at **NIA-R3 Office, Conference Room, Brgy. Tambubong, San Rafael, Bulacan**. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. Bidders must secure Site Inspection Certificate from IMO Office as a technical requirement for Eligibility and Technical Document (Envelop A). Non compliance will be a ground for disqualification.

The **NATIONAL IRRIGATION ADMINISTRATION – REGION 3** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
