Invitation to Bid for the CONSTRUCTION OF CHECK STRUCTURE (BARRAGE TYPE) AND CANAL SYSTEM FOR DAMIRES CIP PHASE II IB No.: NIAR3-ANE-SIP-2025-NE-18

- 1. The National Irrigation Administration Aurora-Nueva Ecija Irrigation Management Office (NIA-ANE-IMO), through the General Appropriations Act for CY 2025 intends to apply the sum of Two Million Seven Hundred Sixty-Nine Thousand Eighty-Seven and 90/100 Pesos Only (Php 2,769,087.90) being the Approved Budget for the Contract (ABC) to payments under the contract for CONSTRUCTION OF CHECK STRUCTURE (BARRAGE TYPE) AND CANAL SYSTEM FOR DAMIRES CIP PHASE II with Project Identification Number IB No.: NIAR3-ANE-SIP-2025-NE-18. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The National Irrigation Administration now invites bids for the above Procurement Project. Completion of the Works is required **One Hundred Fifty (150) Calendar Days**. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
- 4. Interested bidders may obtain further information from National Irrigation Administration Region III Aurora-Nueva Ecija IMO and inspect the Bidding Documents at the address given below from 9:00 am to 3:00 pm (PST).
- 5. A complete set of Bidding Documents may be acquired by interested bidders on June 11, 2025 to June 30, 2025 from Monday to Friday, at 10:00 am to 2:00 pm except on declared holidays, weekends, suspension of work, from given address and website/s below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos Only (PhP 5,000.00).
- 6. The NIA-ANE-IMO will hold a Pre-Bid Conference on June 19, 2025 at 10:00 am at Aurora-Nueva Ecija IMO Aurora Field Office Conference Room, San Luis, Aurora which shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below, on or before **July 1, 2025, at 8:00 am**. Late bids shall not be accepted.

- 8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 16.
- Bid opening shall be on July 1, 2025, at 9:45 am at NIA-ANE IMO Aurora Field, Office, Conference Room, San Luis, Aurora. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
- Bidders must secure Site Inspection Certificate from Engineering Section of ANE IMO signed by the IMO Manager and Duly Notarized Affidavit of Site Inspection as a technical requirement for Eligibility and Technical Document (Envelop A).
- 11. The National Irrigation Administration reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
