- 6. The NIA Zambales IMO will hold a Pre-Bid Conference on April 14, 2025, 1:00 p.m. at NIA Zambales IMO Conference Room, Brgy. Carael, Botolan, Zambales.
- 7. Bids must be duly received by the BAC Secretariat through manual submission and addressed to the BAC Chairperson of the Procuring Entity at NIA Zambales IMO Conference Room, Brgy. Carael, Botolan, Zambales on or before 8:30 a.m. (PST) of April 30, 2025. Late bids shall not be accepted.
- 8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 15.
- 9. Bid opening shall be on 4:00 p.m. (PST) of April 30, 2025 at NIA Zambales IMO Conference Room, Brgy. Carael, Botolan, Zambales. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
- 10. Bidders must secure Site Inspection Certificate from Engineering Section of NIA Zambales IMO as a technical requirement for Eligibility and Technical Document (Envelop A). Non-compliance will be a ground for disqualification.

- 11. Only those who submitted Document Request List (DRL) from PhilGEPS and Letter of Intent including updated company profile by the owner or its authorized liaison officer, will be accepted to participate in the bidding.
- 12. The NIA Zambales IMO reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
