1. The National Irrigation Administration Pampanga-Bataan Irrigation Management Office (NIA PAMBAT IMO) through the CY 2024 GAA projects intends to apply the hereunder Approved Budget for the Contract (ABC) to payment of the corresponding contracts below. Bids received in excess of ABC shall be automatically rejected at bid opening.

2. The National Irrigation Administration Pampanga-Bataan Irrigation Management Office (NIA PAMBAT IMO) now invites bidders for the above-listed contract packages. The description of an eligible bidder is contained in the Bidding Documents, particularly in Section II-Instruction to Bidders. Prospective bidders must have completed a Single Largest Completed Contract (SLCC) that is similar to the project to be bid for the last 3 years, equivalent to at least fifty (50%) of the ABC adjusted, if necessary, by the bidder to current prices using the Philippine Statistics Authority (PSA) consumer price index.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criteria as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act". Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy-five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
4. Interested bidders may obtain further information from the National Irrigation Administration Pampanga-Bataan Irrigation Management Office (NIA PAMBAT IMO) and inspect the Bidding Documents at the address given below. **Submission of Letter of Intent (LOI) together with the PhilGEPS Platinum Certificate, DTI/SEC, Mayor's or Business Permit, PCAB License (Verified at PCAB online verification) and Special Power of Attorney (SPA, if the owner is not present) must be on or before the pre-bidding conference at 10:00 AM to 12:00 NN only, Monday to Friday.**
5. A complete set of Bidding Documents may be purchased by interested Bidders from the address below and upon payment of a non-refundable fee for the Bidding Documents in the amount stated in the above list of packages. It may also be downloaded free of charge from the Website of the Philippine Government Electronic Procurement System (PhilGEPS), provided that bidders shall pay the fee for the Bidding Documents not later than the submission of their bids. Only those in the Document Request List (DRL) are allowed to purchase bidding documents and attend the Pre-Bidding Conference.
6. The National Irrigation Administration Pampanga-Bataan Irrigation Management Office (NIA PAMBAT IMO) will hold a **Pre-Bid Conference on August 30, 2024, 9:00 AM onwards**, at the National Irrigation Administration Pampanga-Bataan Irrigation Management Office (NIA PAMBAT IMO), Solib, Floridablanca, Pampanga which shall be open to all interested bidders.

7. ***Sealed Bids must be delivered until September 11, 2024 with 7:30 AM*** as the deadline for the last day of submission at NIA PAMBAT IMO, Bataan Satellite Office, San Ramon, Dinalupihan, Bataan. ***Bids will be opened on September 11, 2024, 8:00 AM onwards***, in the presence of the bidder (**SPA**, if the owner is not present) who will attend at ***NIA PAMBAT IMO, Bataan Satellite Office, San Ramon, Dinalupihan, Bataan.***
8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 15.
9. The National Irrigation Administration Pampanga-Bataan Irrigation Management Office (NIA PAMBAT IMO) reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.


