1. The National Irrigation Administration-Pampanga Bataan Irrigation Management Office, through the GAA 2025 intends to apply the sum of **Php 42,392,154.41** being the Approved Budget for the Contract (ABC) to payments under the contract ***Improvement of Diversion Dam and Canal System of San Miguel CIS and Pasama IP*** with IB no. ***NIAR3-PAMBAT IMO-2025-SAN MIGUEL CIS/PASAMA IP-04***. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The National Irrigation Administration-Pampanga Bataan Irrigation Management Office now invites bids for the above Procurement Project. Completion of the Works is required ***Two Hundred Forty (240)*** Calendar Days. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "*pass/fail*" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from the National Irrigation Administration Pampanga-Bataan Irrigation Management Office and inspect the Bidding Documents at the address given below from 10:00 AM to 12:00 NN Monday to Friday.
5. A complete set of Bidding Documents may be acquired by interested bidders from October 22, 2024 to November 11, 2024 from 10:00 a.m. to 2:00 p.m., Monday to Friday except for holidays from the given address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **P 25, 000.00**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person. Those only in the Document Request List (DRL) are allowed to purchase Bidding Documents.
6. The National Irrigation Administration Pampanga-Bataan IMO will hold Pre-Bid Conference on ***October 29, 2024 at 9:00 AM*** at ***NIA PAMBAT IMO Office, Solib, Floridablanca, Pampanga***, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through manual submission at NIA PAMBAT IMO, Bataan Satellite Office, San Ramon, Dinalupihan, Bataan on or before ***November 12, 2024 at 7:30 AM*** is the deadline for the last day of submission. Late bids shall not be accepted.
8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ***ITB*** Clause 15.
9. Bid opening shall be on ***November 12, 2024 at 9:30 AM*** in NIA PAMBAT IMO Bataan Satellite Office, San Ramon, Dinalupihan, Bataan. Bids will be opened in the presence of the bidders or bidders' representatives (only with SPA) who choose to attend the activity.

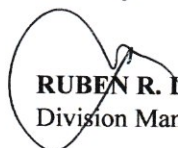
