**Invitation to Bid for the
Improvement of Diversion Works and Canal System of Tinang CIS
IB No. NIA-TAR-2025-10-TINANG CIS**

1. The NIA-Tarlac Irrigation Management Office (NIA-TARLAC IMO), through the General Appropriations Act of CY 2025 intends to apply the sum of Fourteen Million One Hundred Fifty Five Thousand Seven Hundred Forty Three and 74/100 Pesos Only (₱ 14,155,743.74) being the Approved Budget for the Contract (ABC) to payments under the contract for Improvement of Diversion Works and Canal System of Tinang CIS located in the Municipality of Concepcion, Province of Tarlac with IB No. NIA-TAR-2025-10-TINANG CIS. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The NIA – Tarlac Irrigation Management Office now invites bids for the above Procurement Project. Completion of the Works is required within One Hundred Eighty (180) Calendar Days. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from NIA – Tarlac Irrigation Management Office BAC and inspect the Bidding Documents at the address given below from Monday to Friday, from 10:00 a.m. to 2:00 p.m. except holiday.
5. A complete set of Bidding Documents may be acquired by interested bidders on March 28, 2025 to April 15, 2025 from 10:00 a.m. to 2:00 p.m., Monday to Friday, and April 16, 2025 from 8:00 a.m. to 8:30 a.m. except holidays from given address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Fifteen Thousand Pesos (₱ 15,000.00).
6. The NIA – Tarlac Irrigation Management Office will hold a Pre-Bid Conference on April 4, 2025, 10:00 A.M. at NIA- TARLAC IMO Conference Room, Brgy. Jefmin, Concepcion, Tarlac, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through manual submission and addressed to the BAC Vice Chairperson of the Procuring Entity at the office address as indicated below on or before 8:30 a.m. (PST) of April 16, 2025. Late bids shall not be accepted.
8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 15.
