



## Invitation to Bid for

# Repair of Pump Engine, Procurement and Installation of Industrial Diesel Engine, and Well Rehabilitation at Various Tarlac Ground Water Irrigation System of District I

### ITB No. NAR3-2023-TAR-TGIS-12

1. The **NATIONAL IRRIGATION ADMINISTRATION – REGION 3**, through the *General Appropriations Act of CY 2023* intends to apply the sum of *Thirty-Two Million Five Hundred Thirty-Nine Thousand Six Hundred Eighty-Four and 47/100 Pesos Only (P 32,539,684.47)* being the Approved Budget for the Contract (ABC) to payments under the contract *Repair of Pump Engine, Procurement and Installation of Industrial Diesel Engine, and Well Rehabilitation at Various Tarlac Ground Water Irrigation System of District I* located in *Anao, Pura, and Ramos, Tarlac*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **NATIONAL IRRIGATION ADMINISTRATION – REGION 3** now invites bids for the above Procurement Project. Completion of the Works is required *One Hundred Eighty (180) Calendar Days*. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from **NATIONAL IRRIGATION ADMINISTRATION – REGION 3 BAC** and inspect the Bidding Documents at the address given below from Monday to Friday, from 10:00 a.m. to 2:00 p.m. except holiday.
5. A complete set of Bidding Documents may be acquired by interested bidders on April 5, 2023 to April 27, 2023 from 10:00 a.m. to 2:00 p.m., Monday to Friday, and April 28, 2023, 8:00 am to 8:30 am except holidays from given address below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Twenty-Five Thousand Pesos (P 25,000.00).*
6. The **NATIONAL IRRIGATION ADMINISTRATION – REGION 3** will hold a Pre-Bid Conference on April 12, 2023, 9:15 a.m. at **NIA-R3 Office, Conference Room, Brgy. Tambubong, San Rafael, Bulacan**.
7. Bids must be duly received by the BAC Secretariat through manual submission and addressed to the BAC Chairperson of the Procuring Entity at the office address as indicated below on or before **8:30 a.m. (PST) of April 28, 2023**. Late bids shall not be accepted.
8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 15.
9. Bid opening shall be on **9:20 a.m. (PST) of April 28, 2023** at **NIA-R3 Office, Conference Room, Brgy. Tambubong, San Rafael, Bulacan**. Bids will be opened in the presence of the bidders’ representatives who choose to attend the activity.

10. Bidders must secure Site Inspection Certificate from IMO as a technical requirement for Eligibility and Technical Document (Envelope A). Non-compliance will be a ground for disqualification.
11. Only those who submitted Document Request List (DRL) from PhilGEPs and Letter of Intent including updated company profile by the owner or its authorized liaison officer, will be accepted to participate in the bidding.
12. The BAC, if at the time of post-qualification procedure, verifies that any deficiency is due to contractor's fault or negligence pursuant to Section 34.3(b)(ii) of the RA 9184 and its 2016 Revised Implementing Rules and Regulations, the **NATIONAL IRRIGATION ADMINISTRATION – REGION 3** shall disqualify the contractor from the award without any right to reimburse fees and incidental cost paid for the procurement of infrastructure contract subject to the Bid.
13. The **NATIONAL IRRIGATION ADMINISTRATION – REGION 3** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
