## Invitation to Bid for *Repair of Sto. Cristo Dam* IB No. NIAR3-2024-PAM-PGRIS-12

1. The **NATIONAL IRRIGATION ADMINISTRATION – REGION 3**, through the *General Appropriations Act of CY 2024* intends to apply the sum of **Forty-Seven Million Nine Hundred Nineteen Thousand Eight Hundred Sixty-Five and 71/100 Pesos Only (P 47,919,865.71)** being the Approved Budget for the Contract (ABC) to payments under the contract *Repair of Sto. Cristo Dam* with IB No. **NIAR3-2024-PAM-PGRIS-12** located in **Lubao, Pampanga**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **NATIONAL IRRIGATION ADMINISTRATION – REGION 3** now invites bids for the above Procurement Project. Completion of the Works is required **Two Hundred Forty (240) Calendar Days**. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from **NATIONAL IRRIGATION ADMINISTRATION – REGION 3 BAC** and inspect the Bidding Documents at the address given below from **Monday to Friday, from 10:00 a.m. to 2:00 p.m. except holiday**.
5. A complete set of Bidding Documents may be acquired by interested bidders on **January 16, 2024 to February 05, 2024 from 10:00 a.m. to 2:00 p.m., Monday to Friday, and February 06, 2024, 8:00 a.m. to 9:00 a.m. except holidays** from given address below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Twenty-Five Thousand Pesos Only (P 25,000.00)*.
6. The **NATIONAL IRRIGATION ADMINISTRATION – REGION 3** will hold a Pre-Bid Conference on **January 23, 2024, 11:00 a.m.** at **NIA-R3 Office, Conference Room, Brgy. Tambubong, San Rafael, Bulacan**, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through manual submission and addressed to the BAC Chairperson of the Procuring Entity at the office address as indicated below on or before **9:00 a.m. (PST) of February 06, 2024**. Late bids shall not be accepted.
8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 15**.
9. Bid opening shall be on **11:00 a.m. (PST) of February 06, 2024** at **NIA-R3 Office, Conference Room, Brgy. Tambubong, San Rafael, Bulacan**. Bids will be opened in the presence of the bidders’ representatives who choose to attend the activity.
