The **NATIONAL IRRIGATION ADMINISTRATION – REGION 3**, through the **General Appropriations Act of CY 2024** intends to apply the sum of **Fifty-Seven Million Seven Hundred Eighty-One Thousand Seven Hundred Sixty-Six and 28/100 Pesos Only (P 57,781,766.28)** being the Approved Budget for the Contract (ABC) to payments under the contract **Repair of Check Structure along Bayating River with Installation of Steelgate, Repair of Damaged Check and Canalization at Main Canal Sta 13+014, Proposed Furnishing and Installation of 4-units of Intake Gates of Tanggal Kumon and 2 units of Intake Gates of Tanggal Baybayaoas, and Concreting of Canal Lining, Two Units Road Crossing & Concreting of Road of Camiling RIS** with IB No. **NIAR3-2024-TAR-CAMILING RIS-6** located in **Camiling, Mayamoc, and Sta. Ignacia, Turiac**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **NATIONAL IRRIGATION ADMINISTRATION – REGION 3** now invites bids for the above Procurement Project. Completion of the Works is required **Three Hundred (300) Calendar Days**. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from **NATIONAL IRRIGATION ADMINISTRATION – REGION 3 BAC** and inspect the Bidding Documents at the address given below from **Monday to Friday, from 10:00 a.m. to 2:00 p.m. except holiday**.
5. A complete set of Bidding Documents may be acquired by interested bidders on **December 06, 2023 to December 26, 2023 from 10:00 a.m. to 2:00 p.m., Monday to Friday, and December 27, 2023, 8:00 a.m. to 9:00 a.m. except holidays** from given address below **and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Fifty Thousand Pesos Only (P 50,000.00)**.
6. The **NATIONAL IRRIGATION ADMINISTRATION – REGION 3** will hold a Pre-Bid Conference on **December 14, 2023, 11:40 a.m.** at **NIA-R3 Office, Conference Room, Brgy. Tambubong, San Rafael, Bulacan**, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through manual submission and addressed to the BAC Chairperson of the Procuring Entity at the office address as indicated below on or before **9:00 a.m. (PST) of December 27, 2023**. Late bids shall not be accepted.





9. Bid opening shall be on **1:00 p.m. (PST) of December 27, 2023** at **NIA-R3 Office, Conference Room, Brgy. Tambubong, San Rafael, Bulacan**. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

The **NATIONAL IRRIGATION ADMINISTRATION – REGION 3** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
