



Invitation to Bid for *Construction of Canal Lining of Lubigan CIS, Canalization Works and Farm-to-Market Road at David CIS, and Canalization Works at Iba-Sula CIS*

1. The **NATIONAL IRRIGATION ADMINISTRATION – REGION 3**, through the *General Appropriations Act of CY 2024* intends to apply the sum of **Forty-One Million Nine Hundred Sixty-Five Thousand One Hundred Sixteen and 86/100 Pesos Only (P 41,965,116.86)** being the Approved Budget for the Contract (ABC) to payments under the contract *Construction of Canal Lining of Lubigan CIS, Canalization Works and Farm-to-Market Road at David CIS, and Canalization Works at Iba-Sula CIS* with IB No. **NIAR3-2024-TAR-LUBIGAN CIS-DAVID CIS-IBA-SULA CIS-7** located in **San Jose, Tarlac**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **NATIONAL IRRIGATION ADMINISTRATION – REGION 3** now invites bids for the above Procurement Project. Completion of the Works is required **One Hundred Eighty (180) Calendar Days**. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from **NATIONAL IRRIGATION ADMINISTRATION – REGION 3 BAC** and inspect the Bidding Documents at the address given below from **Monday to Friday, from 10:00 a.m. to 2:00 p.m. except holiday**.
5. A complete set of Bidding Documents may be acquired by interested bidders on **December 06, 2023 to December 26, 2023 from 10:00 a.m. to 2:00 p.m., Monday to Friday, and December 27, 2023, 8:00 a.m. to 9:00 a.m. except holidays** from given address below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of* **Twenty-Five Thousand Pesos Only (P 25,000.00)**.
6. The **NATIONAL IRRIGATION ADMINISTRATION – REGION 3** will hold a Pre-Bid Conference on **December 14, 2023, 1:20 p.m.** at **NIA-R3 Office, Conference Room, Brgy. Tambubong, San Rafael, Bulacan**, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through manual submission and addressed to the BAC Chairperson of the Procuring Entity at the office address as indicated below on or before **9:00 a.m. (PST) of December 27, 2023**. Late bids shall not be accepted.
8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 15**.
