Ma'am,

Please be informed that the contract for the project Construction of Various Solar Powered Pump Irrigation Projects for Aurora, Nueva Ecija, Bulacan, and Pampanga located at Maria Aurora, and Casiguran, Aurora; Licab, Cuyapo, and Cabiao, Nueva Ecija; Angat, Bulacan; Candaba, Pampanga with Contract No. NIAR3-2024-SOLAR-40 has been awarded to 11-16 CONSTRUCTION in the amount of Two Hundred Thirty-Six Million Two Hundred Nine Thousand Three Hundred Eighty and 74/100 Pesos Only (PhP 236,209,380.74);

- b) Performance Bond, callable on demand issued by GSIS or by a Surety or Insurance Company duly accredited by the Insurance Commissioner in the amount of **P 70,862,814.22**.

Also, submit a complete construction program, for approval of NIA, for the orderly performance of the contract works, to wit;

- 1. PERT/CPM;
- 2. Equipment Utilization Schedule;
- 3. Manpower Utilization Schedule;
- 4. Construction Safety and Health Program (CSHP) approved by DOLE; and
- 5. Affidavit of Site Inspection

It is requested that the above-mentioned requirements be complied with and upon satisfactory compliance thereof, enter into a contract with NIA in accordance with the terms and conditions of the contract documents.

In the event you fail for whatever reason to execute the contract and/or satisfy the above requirements within ten (10) calendar days from receipt of this notice, it shall be understood that you are no longer interested in the contract. The NIA therefore, shall have the option not to award the contract and declare failure of bidding and likewise, your bid security will be forfeited.
