Please be informed that the contract for the project **Construction of Various Solar Powered Pump Irrigation Projects for Pampanga and Bataan** located at Lubao, Guagua, and Porac, Pampanga; and Pilar, and Dinalupihan, Bataan with Contract No. **NIAR3-2025-PAMBAT-SOLAR-4** has been awarded to **EDDMARI CONSTRUCTION & TRADING** in the amount of **One Hundred Fifty-Nine Million Seven Hundred Thirty Thousand Five Hundred Sixty-Nine and 91/100 Pesos Only (Php 159,730,569.91)**;

- b) Performance Bond, callable on demand issued by GSIS or by a Surety or Insurance Company duly accredited by the Insurance Commissioner in the amount of **P 47,919,170.97**.

Also, submit a complete construction program, for approval of NIA, for the orderly performance of the contract works, to wit;

1. PERT/CPM;
2. Equipment Utilization Schedule;
3. Manpower Utilization Schedule;
4. Construction Safety and Health Program (CSHP) approved by DOLE; and
5. Affidavit of Site Inspection

It is requested that the above-mentioned requirements be complied with and upon satisfactory compliance thereof, enter into a contract with NIA in accordance with the terms and conditions of the contract documents.

In the event you fail for whatever reason to execute the contract and/or satisfy the above requirements within ten (10) calendar days from receipt of this notice, it shall be understood that you are no longer interested in the contract. The NIA therefore, shall have the option to consider awarding the contract to the second-lowest bidder and likewise, your bid security will be forfeited.
