Please be informed that the contract for the Improvement & Rehabilitation of Diversion Works and Canal System of STRIS (Castillejos) located at Castillejos, Zambales with Contract No. NIA-ZAM-2025-08-STRIS (CASTILLEJOS)-1 has been awarded to E.T. CASTRO CONSTRUCTION AND SUPPLIES in the amount of Twenty Three Million Two Hundred Ninety Two Thousand Nine Hundred Seventy Five & 70/100 Pesos Only (**P** 23,292,975.70);

In this connection, you are hereby requested to submit the Performance Security in the amount and form in either one of the following or a combination thereof;

- o) Cash, Manager's Check, Cashier's Check, Irrevocable Letter of Credit issued by a reputable bank in the amount of **P** 2,329,297.57.
- p) Performance Bond, callable on demand issued by GSIS or by a Surety or Insurance Company duly accredited by the Insurance Commissioner in the amount of **P** 6,987,892.71

Also, submit a complete construction program, for approval of NIA, for the orderly performance of the contract works, to wit;

- 1. PERT/CPM;
- 2. Equipment Utilization Schedule;
- 3. Manpower Utilization Schedule; and
- 4. Construction Safety and Health Program (CSHP) approved by DOLE.

It is requested that the above-mentioned requirements be complied with and upon satisfactory compliance thereof, enter into contract with NIA in accordance with the terms and conditions of the contract documents.

In the event you fail for whatever reason to execute the contract and/or satisfy the above requirements within ten (10) calendar days from receipt of this notice, it shall be understood that you are no longer interested in the contract. The NIA therefore, shall have the option to consider awarding the contract to the second lowest bidder and likewise your bid security will be forfeited.
