Please be informed that the contract for the project Rehabilitation and Slope Protection Works of Dalao Dam, Repair of Diversion Dam of Saysain CIP, and Repair of Collapsed Elevated Flume and Slope Protection of Apangin CIS located at Bagac and Dinalupihan, Bataan – Contract No. NIAR3-2023-TYP-BAT-1 has been awarded to E.T. 2. Equipment Utilization Schedule;
3. Manpower Utilization Schedule; and
4. Construction Safety and Health Program (CSHP) approved by DOLE.
5. Affidavit of Site Inspection

It is requested that the above-mentioned requirements be complied with and upon satisfactory compliance thereof, enter into contract with NIA in accordance with the terms and conditions of the contract documents.

In the event you fail for whatever reason to execute the contract and/or satisfy the above requirements within ten (10) calendar days from receipt of this notice, it shall be understood that you are no longer interested in the contract. The NIA therefore, shall have the option to consider awarding the contract to the second lowest bidder and likewise your bid security will be forfeited.
