Please be informed that the contract for the **Improvement of Canal System of PGRIS (Gumain RIS)** located at **Lubao, Pampanga** with Contract No. **NIAR3-PAMBAT IMO-2025-PGRIS (GUMAIN RIS)-02** has been awarded to **DMKC CONSTRUCTION AND TRADING CORP.** in the amount of **EIGHTEEN MILLION NINE HUNDRED SEVENTY-EIGHT THOUSAND THREE HUNDRED SIXTY-SEVEN PESOS AND FIFTY-THREE CENTAVOS ONLY (PHP 18,978,367.53).**

In this connection, you are hereby requested to submit the Performance Security in the amount and form in either of the following or a combination thereof;

- a) Cash, Cashier's/Manager's Check, Bank guarantee/Irrevocable Letter of credit confirmed by the Bank in the amount of **₱1,897,836.75.**
- b) Performance Bond callable upon demand issued by a surety or insurance company duly certified by the Insurance Commission as authorized to issue such security in the amount of **₱ 5,693,510.26.**

Also, submit a complete construction program for approval of NIA, for the orderly performance of the contract work, to wit;

1. PERT/CPM
2. Equipment Utilization Schedule
3. Manpower Utilization Schedule
4. Construction Safety & Health Program
5. Construction Methods

It is requested that the above-mentioned requirements be complied with and upon satisfactory compliance thereof, enter into a contract with NIA in accordance with the terms and conditions of the contract documents.

In the event you fail for whatever reason to execute the contract and/or satisfy the above requirements within ten (10) calendar days from receipt of this notice, it shall be understood that you are no longer interested in the contract. The NIA therefore, shall have the option to consider awarding the contract to the second-lowest bidder and likewise, your bid security will be forfeited.
