Please be informed that the contract for the Improvement of Canal System of CLBRIS (Layac-Balsik RIS) located at Hermosa, Bataan with Contract No. NIAR3-PAMBAT IMO-2025-CLBRIS (LAYAC-BALSIK RIS)-17 has been awarded to TDC II PRO BUILDERS in the amount of NINE MILLION FOUR HUNDRED EIGHT THOUSAND EIGHT HUNDRED TWENTY-NINE PESOS AND FIFTY-ONE CENTAVOS ONLY (PHP 9,408,829.51).

It is requested that the above-mentioned requirements be complied with and upon satisfactory compliance thereof, enter into a contract with NIA in accordance with the terms and conditions of the contract documents.

In the event you fail for whatever reason to execute the contract and/or satisfy the above requirements within ten (10) calendar days from receipt of this notice, it shall be understood that you are no longer interested in the contract. The NIA therefore, shall have the option to consider awarding the contract to the second-lowest bidder and likewise, your bid security will be forfeited.
